
**A PUBLIC HEARING WAS SCHEDULED AND ADVERTISED TO BE HELD AS A

That, in accordance with the requirements of Chapter 40, Section 56 of the Massachusetts General Laws, as amended by Chapter 369 of the Acts of 1982, the City of Everett hereby considers approving the adoption of the lowest minimum residential factor (MRF) of 0.XXXXXX as determined by the Commonwealth of Massachusetts' Commissioner of Revenue for Fiscal Year 2025 that began on July 1, 2025 and ends on June 30, 2026.
